

Domestic Abuse Intervention Services, Madison, Wisconsin

DAIS is the only domestic abuse shelter in Dane County. It Empowers those affected by domestic violence and advocate for social change through support, education, and outreach.

MEN'S Club

This is one of DAIS' main prevention initiatives. MEN'S Club, which stands for Men Encouraging Nonviolent Strength, works with high school-aged male youth and provides a minimum of 10 sessions that focus on gender roles and expectations, communication, conflict resolution, and healthy and less-healthy relationships. Each session is discussion and activity-based and is about 50 minutes long. Sessions are co-facilitated by DAIS and school/organization staff, and encourage peer leadership.

MENS Club participants have presented to fellow students and faculty, middle school students and state-wide audiences at conferences about what they've learned during their MEN'S Club experience. The current MENS Club partner sites include:

Ending Early Marriage - Survivor Recovery Stories - US

Child marriage remains legal in 46 US States and is happening in the U.S. at an alarming rate: Some 248,000 children some as young as age 12 were married in the U.S. between 2000 and 2010.

The U.S. State Department has called marriage before 18 a "human rights abuse" that "produces devastating repercussions for a girl's life, effectively ending her childhood." This leaves a young girl vulnerable to poverty, early pregnancy, abuse and lack of education. Many states have been working to enact laws that make it illegal to marry before the age of 18 even with parental consent.

Survivors' Corner Mobilizes Change in Kentucky

"With the support of many advocates and victims' rights centric partners, we successfully spearheaded Kentucky Senate Bill 48, which put an end to children marrying through parental consent in the state of Kentucky. Luiza Karimova Personal Story

When she was 22 years old, Luiza Karimova left her home in Uzbekistan and travelled to Osh, Kyrgyzstan with the hopes of finding work. However, without a Kyrgyz ID or university degree, Karimova struggled to find employment. When a woman offered her a waitressing job in Bishkek, the capital city in the north of Kyrgyzstan, she welcomed the opportunity. But things took a turn for the worse after arriving in Bishkek. Karimova recalls that, "They held us in an apartment and took away our passports.

For 18 months, her life was consumed by the nightclub work. Upon leaving the club one evening, Karimova saw a police car approaching, and instead of running away, she stayed to let the police arrest her. "I was deported back to Osh, and since my ID was fake, I spent a year in jail. I filed a police report, and three of the traffickers were captured".

After being released from prison, Karimova was approached by Podruga, an organization that assists women subjected to sex and drug trafficking. "They offered me work. Slowly I began to trust them," she says. Now, Karimova works to prevent the exact situation in which she found herself. As an outreach worker with Podruga, she visits saunas and other places where sex workers may be. "I often meet girls who dream of going to Turkey and Dubai, to earn more. 

"There's no such thing as a child prostitute," says LaTonya Johnson (D-Milwaukee). "These children are not capable of giving consent." Children facing charges of prostitution have been used by prosecutors to testify against pimps. Authorities sometimes send child victims of trafficking to juvenile detention facilities, to keep them off the streets because so few shelters are available.

UN Sustainable Development

Gender equality is not only a fundamental human right, but a necessary foundation for a peaceful, prosperous and sustainable world.

There has been <u>progress</u> over the last decades: More girls are going to school, fewer girls are forced into early marriage, more women are serving in parliament and positions of leadership, and laws are being reformed to advance gender equality.

Despite these gains, many <u>challenges</u> remain: discriminatory laws and social norms remain pervasive, women continue to be underrepresented at all levels of political leadership, and 1 in 5 women and girls between the ages of 15 and 49 report experiencing physical or sexual violence by an intimate partner within a 12-month period.

The effects of the COVID-19 pandemic could reverse the limited progress that has been made on gender equality and women's rights. The coronavirus outbreak exacerbates existing inequalities for women and girls across every sphere – from health and the economy, to security and social protection.

Ending Sexual Assault - Global

Rape – a single word with devastating impact that spans decades, even generations. It destroys bodies and minds and puts peace in jeopardy. When left unpunished or trivialized, it creates a pervasive culture where sexual violence is normalized, women and girls are undervalued, and entire communities and nations are left fractured.

You know the stories – "Boys will be boys." – or – "She was drunk." – or – "Women say "no" when they mean "yes." Rape culture is the social environment that allows sexual violence to be normalized and justified, fueled by the persistent gender inequalities and attitudes about gender and sexuality. Naming it is the first step to dismantling rape culture.
